# Subject: Submission Of Compliance Certificate by Depository Participants

- (a) Act / Regulations / Rules / Directives / Notification / Circulars / Clarifications / Guidelines issued by IFSCA, the Government of India, Regulatory Bodies and IIDI, from time to time.
- (b) The Bye Laws of IIDI.
- (c) IFSCA (Anti Money Laundering, Counter Terrorist-Financing and Know Your Customer) Guidelines, 2022, as updated from time to time and the Rules and Guidelines notified thereunder by Statutory / Regulatory Authorities.

In this regard, Depository Participants are advised to submit a 'Compliance Certificate' to IIDI in the format given in **Annexure I** (Compliance Certificate) duly signed and stamped by the Compliance Officer of the Depository Participants.

The first compliance certificate period [FY 2024-25] is to be submitted by May 31, 2025 and henceforth at the end of every quarterly interval of Financial years (April to June, July to September, October to December and January to March to be submitted by July 30, October 31, January 31 and April 30 of every year respectively).
